The City of Cincinnati has championed revitalization projects in Bond Hill and Roselawn by providing significant capital funding for the Port Authority's redevelopment work in these neighborhoods. The Port has leveraged public funds with grants and private capital, as well as impact investment. Through a variety of funding and development agreements

centered on transforming the neighborhoods' disinvested properties, the Port Authority has led acquisition and redevelopment of more than 80 acres.




